November 12, 2024

Mayor Henner called the meeting to order at 7:00 pm with the Pledge of Allegiance.

Fire Department-Ryan Henry-absent

The approved and signed Town of Huron Fire Protection contract was presented to be signed. Mayor Henner signed and Fire Chief Henry will be notified contract received and he needs to sign. Clerk-Treasurer Acker will then send copy back to the Town of Huron.

Police Department-Brian Ritchie-absent

Highway Department-Chris Breen

Mr. Breen mentioned the Highway Department has been picking up raked leaves around the village. They are also getting plow trucks ready for the winter season.

Chris Breen is looking into new Christmas lights for Main Street.

Trustee Smith mentioned he has noticed some residents are putting leaves in the street. Mr. Breen said he has spoken to some people. The leaves end up in the storm drains. Trustee Smith recommended speaking with Police Officer Costello and if needed, the Village Hall can send a letter to those residents who continue to put leaves in the streets.

Sewer Department-Tommy Mettler

Tommy Mettler reported the pump stations are all good. There were issues with pump #2 for a while. There was a rattle when it was started. Rick from Plantech happened to stop in and found there was a bad bearing in this pump.

Trustee Smith the motion to approve Plantech quote to rebuild pump #2 bearings not to exceed the amount of 3,500.00. Trustee Harper 2^{nd} the motion. All present voted in favor.

Water Department-Ed Wazinski

Mr. Wazinski stated the water department has a defective turbidmeter. He presented a quote from Hach to replace. Trustee Smith made the motion to approve Hach Quote #101115491v4 in the amount of \$5,470.00. Trustee Harper 2nd the motion. All present voted in favor.

Mr. Wazinski has started the annual sanitary survey needed for the Department of Health.

A couple of shut offs in the village have been done due to non-payment.

Trustee Smith made the motion to accept monthly payments for account #20510 in the amount of \$100.00 until paid and all current bills must be kept current. The outstanding amount is \$221.11. Trustee Marshall 2nd the motion. All present voted in favor.

Deputy Clerk-Treasurer Banas-Duncan presented the open past due water and sewer accounts. Total has decreased to \$19,550.05. Once outside outstanding accounts presented to the board, vacant properties and those with payment plans are removed, the outstanding balance is \$4,631.09.

Justice Court

Trustee Smith made the motion to accept and approve the Village of Wolcott Justice Court's audit for September 2024. Trustee Marshall 2nd the motion. All present voted in favor.

Village Clerk/Treasurer

2 estimates to makeover the Village of Wolcott website has been received. Trustee Smith made the motion to accept the bid from Jack Roberts in the amount of \$3,100.00 to be funded by ARPA funds. Future hosting costs will be billed at \$400.00 per year to include updates and some support as needed. Major reconstruction will be billed at \$50/hour and minor administrative revisions will be performed at no cost. Trustee Lewis 2nd the motion. All present voted in favor.

Trustee Smith made the motion to approve pre-payment of the annual NYSLRS ERS invoice in the amount of \$53,489 to take advantage of the early pay discount. Trustee Lewis 2nd the motion. All present voted in favor.

Trustee Smith made the motion to approve pre-payment of the annual NYSLRS PFRS invoice in the amount of \$12,262 to take advantage of the early pay discount. Trustee Lewis 2nd the motion. All present voted in favor.

ARPA Funds Obligation

Estimates were received to replace the Northrup Park Gazebo roof that ranged from \$8,000 -\$16,900 depending on what shingles were used. Also estimates to purchase an event tent for the Village of Wolcott events that ranged from \$350.00-\$13,000 depending on the size and material.

Approval for 2-3 grills for Falls Park. The cost of qty (3) will be \$450.00. ARPA funds will be used to fund. Mayor Henner asked Highway Working Foreman Chris Breen to look at what barriers are needed for Falls Park. The cost of new rock barriers will be covered by ARPA Funds.

The discussion of tents and the gazebo roof was tabled until the December 10, 2024 meeting.

Correspondences

The brother of the man missing from the Family Dollar reached out to the Village Hall on the anniversary of him going missing. The brother and the family wanted to send their appreciation for the Village's support during the difficult time. They will be back at some point to hand more flyers and spread the word. He appreciated the continued support and commented on how nice the hotel was.

Mayor Henner

Mayor Henner mentioned issues that have happened on East Port Bay Road and Oswego Street with vehicles damaging the wall. Mayor Henner reached out to Kreher's Poultry Farms 1st speaking with an Engineer who provided a contact name. The Mayor spoke with Nicole Mastrangelo who confirmed the business does have a designated route but drivers use GPS which sends them a different way. Mayor Henner thanked Mr. Gow for providing names of trucks that are taking the incorrect route. Mayor Henner will continue to follow up with Kreher's. R permits can be designated if needed, but is hoping not to get to that point.

Mayor Henner spoke with Fire Chief Henry regarding Clifton Springs Fire Department is pulling a platform ladder truck and wants \$25,000.00. The Village of Clifton Springs has had several inquiries and they will keep the Village of Wolcott on the list of interest.

Trustee Harper

Trustee Smith made the motion for the Village of Wolcott to partner with Melissa Kersten at Finger Lakes Action Program to utilize an \$8,0000.00 grant for some Village of Wolcott improvements. Trustee Harper and Chris Breen are leads of the program. Trustee Marshall 2nd the motion. All present voted in favor.

Trustee Marshall

Trustee Marshall asked Highway Foreman Chris Breen if he had an update on Christmas lights for Main Street. An order is being worked on.

Trustee Marshall inquired on "welcome to Wolcott" sign on Route 104 that a tree fell through. Mayor Henner asked Mr. Breen to reach out to Pilat for information on new banners for the signs. The Mayor did mention he didn't want to step on any toes of those who are responsible for the sign.

Trustee Smith

Nothing at this time.

Trustee Lewis

Trustee Lewis stated the Hometown Hero Banners would be taken down by the end of November and put back up for Memorial Day. The banners can still be ordered.

Trustee Lewis also inquired about the status of a tree on Cemetery Street. Chris Breen has on the list for Bob Crane's Tree Service.

Time for the Public

Mayor Henner asked Matt Ohler about the paint that was put on pavement and sidewalks for the 5K. Mr. Ohler stated this was temporary. Mr. Ohler was asked how temporary and that the understanding is that chalk was being used.

Mayor Henner said NYMIR provided safety tips on 5K and festival. Matt Ohler asked if this could be forwarded to him.

Executive Session

Trustee Smith made the motion to move the meeting to executive session for a contractual matter at 7:48pm. Trustee Lewis 2nd the motion. All present voted in favor. Water Department Head Ed Wazinski, Sewer Department Head Tommy Mettler and Clerk-Treasurer Acker stayed. Mr. Mettler left the meeting at 8:37 pm. Mr. Wazinski left at 8:47 pm. Clerk-Treasurer Acker remained in the executive session.

Trustee Smith made the motion to move the meeting back to regular session at 8:48 pm. Trustee Lewis 2^{nd} the motion. All present voted in favor.

Clerk-Treasurer Acker was asked to send the 3 delinquent water bills for outside customers to the Village Attorney to review and recommend the next steps.

Trustee Smith made the motion to increase sewer rates by 22% effective December 1, 2024 for accounts 13410 and 13415. A notice will be sent explaining and that no increase has been done for several years. Trustee Harper 2nd the motion. All present voted in favor.

Trustee Smith made the motion to approve Viaesys quote for weather software for the Village staff in an amount not to exceed 6,500.00 to be funded by ARPA funds. Clerk Acker will reach out to the company to get a quote adding 2 more years. Trustee Marshall 2^{nd} the motion. All present voted in favor

Trustee Lewis will reach out and get another quote for the gazebo roof.

Trustee Marshall left at 9:23 pm.

Clerk-Treasurer Acker made the remaining board aware that the Lexmark Printer is beyond repair. Deputy Clerk-Treasurer Banas-Duncan will look into a replacement printer that is inexpensive to replace ink.

Trustee Smith made the motion to adjourn the meeting at 9:34 pm. Trustee Harper 2^{nd} the motion. All still present voted in favor.
