## **Time for Public**

George Buckalew asked if dog complaints count towards the property abatement nuisance law. This continues to be an ongoing issue in some areas of the Village.

Chris Trine thanked the Highway Department for addressing the "ponding" issue on his street that was mentioned at a previous Village Board meeting.

The Village Trustees complimented Peter Sterpe on a successful 1<sup>st</sup> Pickin in the Park which he put together on May 23, 2024.

# Purchase of 2002 Freightliner

Trustee Smith made the motion to approve Trustee Marshall purchasing a 2002 Freightliner FLD112 with 82,000 miles for the Highway Department in an amount not to exceed \$20,000.00. Trustee Marshall  $2^{nd}$  the motion. All present voted in favor.

#### **Parks**

Trustee Smith made the motion to approve purchase of the Lucky Star playground Equipment from vendor <u>The Amish Peddler</u> not to exceed the amount of \$23,135.00. Trustee Lewis 2<sup>nd</sup> the motion. All present voted in favor. Trustee Harper will reach out to the vendor to place the order. The Village Trustees would like to have installed by June 15, 2024 to coincide with the Strawberry Festival. Trustee Harper will inquire if this is possible.

#### **Water Plant RFQ**

The LaBerge Group and Clark Patterson Lee were the 2 RFQ's received. Trustee Smith made the motion to accept Clark Patterson Lee's RFQ for the water plant improvement project. Trustee Lewis 2<sup>nd</sup> the motion. Trustees Marshall and Harper voted nay for Clark Patterson Lee and wanted to award to The LaBerge Group. Trustees Smith and Lewis along with Mayor Henner voted in favor of Clark Patterson Lee.

Trustee Smith made the motion to have the 2 new speed signs previously approved to purchase be paid out of ARPA funds. Trustee Lewis 2<sup>nd</sup> the motion. All present voted in favor.

Trustee Smith made the motion to adjourn the meeting at 8:32pm. Trustee Lewis 2nd the motion. All present voted in favor.
