Mayor Henner called the meeting to order at 7:00 pm with the Pledge of Allegiance.

Rene' Musso

Rene' Musso is the owner of the Coughie Shop and has asked the board to review the letter she previously submitted wanting a variance to the Cannabis locations previously approved by the Village of Wolcott Board. She would like a response by Friday, January 17, 2025 if possible.

Fire Chief-Ryan Henry

Fire Chief Henry presented the Wolcott Fire Department purchased a Chief's Vehicle and is asked that the Village of Wolcott pay for the insurance and registration. The Fire Department will be responsible for maintenance and fuel. Mayor Henner asked various questions and that there are several considerations that should have been discussed with the Village Board before purchase not after. Fire Chief Henry stated he had reached out to Eastern Shore Insurance. Clerk-Treasurer Acker has also. The Village Clerk-Treasurer will continue to work with the insurance company to get coverage clarification and an estimate. Fire Chief Henry stated only \$900 of the department's insurance budget has been spent so far. Clerk-Treasurer Acker reminded him that amount was due to changes throughout this fiscal year and that the insurance company and reach out to NYCOM for further information.

Deputy Clerk-Treasurer presented the Village of Wolcott Board a proposed "Welcome to Wolcott" information sheet as requested by Trustee Smith during the December 10, 2024 board meeting. Mayor Henner suggested information for textmygov be added. Everything else looks great.

The Village Board was presented the shut off list for water/sewer accounts. The Deputy Clerk-Treasurer has been making phone calls to those on the list.
